

# 3 LIES

## CONSERVATIVES ARE BEING TOLD

### To **FOOL Them** Into Supporting the Wrong “Health Freedom” Bill

#### LIE #1: Both bills prevent vaccine passports.

This is absolutely FALSE. Only HB305/SB222 the “**Health Freedom Civil Rights Bill**” *prevents vaccine passports and vaccine mandates*. The other bill, HB1013/SB252 the “**Big Pharma Fool You Bill**,” *only applies to COVID 19 vaccines*. It is designed this way intentionally so that the bill will be effectively meaningless against the next pandemic and any future vaccines since the next health crisis will not be “COVID 19.” This bill also doesn’t apply to any other vaccine other than COVID-19 vaccines. This is why BIG PHARMA supports this bill because it fools conservatives into thinking they are stopping tyranny, when in reality, the bill is totally worthless.

#### LIE #2: HB305/SB222 the “Health Freedom Civil Rights Bill” puts additional burdens on private businesses.

This is an absolute lie. The “**Health Freedom Civil Rights Bill**” does not create any new burdens or requirements on private businesses. It simply amends the EXISTING CIVIL RIGHTS STATUTE (which all private businesses already must abide by), to include “*vaccine and immunity status*.” This effectively prevents vaccine passports and vaccine mandates for ALL vaccines (not just COVID-19 vaccines) and keeps your health information private!

#### LIE #3: Both bills are supported by Conservatives and they’re both good bills.

The truth is that the only “conservatives” who support HB1013/SB252 (the “Big Pharma Fool You Bill”) are those who have *never actually read the bill!* They are being fooled by BIG PHARMA. ***This bill is being supported and lobbied for by GlaxoSmithKline (a major vaccine manufacturer) and was only created to prevent HB305/SB222 (the “Health Freedom Civil Rights Bill”) from being passed.*** On the contrary, HB305/SB222 is supported by Health Freedom Florida, Children’s Health Defense Florida, Stand for Health Freedom, Health Freedom Institute, Florida Moms for America, Women Impacting the Nation, Health Freedom Defense, Freedom Keepers, and nearly all advocates of Freedom and Body Sovereignty!
